

# ARTIST TERMS & CONDITIONS

## 1. INTRODUCTION

By registering as an artist on FINEART.gallery, you agree to abide by the terms and conditions outlined below.

## Legal Information

FINEART.gallery is a registered trademark by SARL ARTEFACT COLLECTION, headquartered at 8 rue du Baou, 06610 La Gaude, France. Director: Loïc KERNEN. For any inquiries, you can contact us at [contact@fineart.gallery](mailto:contact@fineart.gallery).

## 2. ARTIST ELIGIBILITY & ARTWORK APPROVAL

Only artists submitting original artworks that meet FINEART's quality and artistic vision will be accepted. All submissions must also meet the technical requirements outlined in the Submission Guide.

FINEART reserves the right to refuse any artist or artwork at its sole discretion and without providing reasons.

## 3. PRICING COMMISSION & TAXES

Artworks will be sold in the following formats and final selling prices (tax excluded):

- SMALL: 100 EUR (Artist Commission: 30 EUR)
- MEDIUM: 200 EUR (Artist Commission: 60 EUR)
- LARGE: 375 EUR (Artist Commission: 120 EUR)
- LUXE: 625 EUR (Artist Commission: 240 EUR)

EU-based artists will receive payment of commissions + 20% tax.

Non EU-based artists will receive payment of commissions + 0% tax.

## 4. PAYMENTS

Payments are processed monthly via PayPal only, on the 28th of each month.

A PayPal account is required to receive commissions.

A 14-day hold is applied after an artwork is received by the customer, during which returns can be requested without reason.

If no active Paypal account is registered in the artist's Vendor Dashboard (<https://fineart.gallery/dashboard/vendor-billing/>), FINEART will not be able to disburse commissions.

## 5. FILE STORAGE & SECURITY

Your uploaded artwork files are securely stored in our offline lab server and are never shared with third parties. If your account is closed, all files will be permanently deleted from our database.

## 6. USE OF ARTWORKS

FINEART may use your artworks for the promotion of the platform or to sell in the formats listed above.

Promotional use will always be credited to you, and we will request your approval before usage.

**7. RETURNS & REFUNDS**

In the event of a customer return, the related commission will be deducted from your next payout.

**8. TERMINATION**

FINEART reserves the right to terminate your account if the terms are violated or artworks do not align with our artistic vision.

**9. GOVERNING LAW**

These terms are governed by the laws applicable in France.
